Updates on IANA Transition and ICANN Accountability

The IANA Stewardship Transition Coordination Group (ICG) and Cross Community Working Group on Enhancing ICANN Accountability (CCWG-Accountability) have submitted their proposals to the National Telecommunications and Information Administration (NTIA) on 10th March, 2016.

Before they can complete their anticipated 90 day review, NTIA has said they need to see some adoption of changes to ICANN's Bylaws, to reflect the recommendations in those Proposals.

Therefore, to ensure this timeline, a drafting team was constituted comprising of the ICANN legal team and two external law firms who were involved with CWG-Stewardship and CCWG-Accountability working groups and the two communities, to develop the Draft New ICANN Bylaws

Both the independent counsel to the community groups and ICANN's General Counsel have confirmed that the Draft New ICANN Bylaws are consistent with the community proposals relating to the IANA Stewardship Transition.

As a next step the comments would be analyzed and incorporated for a tentative 27th May adoption of the Bylaws by the ICANN Board.

Discussion on APAC Participation in GNSO

The APAC Hub of ICANN organized an hour long Web Conference to discuss on the APAC Participation in GNSO. Apart from ICANN staff, there were 49 participants, including 3 from India.

The discussion was lead by Jia-Rong Low, VP and MD APAC Hub, ICANN, Edmon Chung, CEO DotAsia and Joyce Chen, GSE Strategy & Development Senior Manager, ICANN.

The participants were given a brief introduction to the structure, mandate and membership process of the GNSO, along with an overview of the key issues being discussed such as ongoing Policy Development Processes (PDP) and Public Comment opportunities in GNSO.

During the discussion poor participation from APAC region @ GNSO was observed to be of prime concern. The participants were encouraged to share their views on what the reasons behind this low participation and also what could be the recommendations to improve this anomaly.

There were various suggestions shared, such as having policies being translated into regional languages, holding GNSO calls at a convenient time, mentoring, checking past data of participation and travel support. Participants also suggested that ICANN needs to also check the reason behind non participation of many existing members.

On behalf of CCAOI, Director, Amrita Choudhury shared the Indian perspective stating that most business houses including ISP's in India do not see the value in participating in these discussions or forums, as they cannot visualize any gains by participating in them. Moreover, existing GTLDs are more involved in enhancing their business and are not keen to delve into policy related matters, further they do not have the manpower with requisite skill sets to involve in policy making.

To correct the existing circumstances, she stated that there is a serious need for ICANN to increase their outreach activity amongst the community, not only to educate them but also to create awareness of what the community is missing by not participating in policy formulation discussions.

She also suggested that ICANN should think of simplifying the existing policy documents and then sharing them in a concise form with the business community, explaining the issue, various suggestions and their implications, so that they can respond easily.

Further, ICANN should think of having regional champions who can create awareness amongst the community, sharing and taking their views and then passing the same to ICANN. If required with the support of ICANN these local champions can conduct events or workshops for better participation. ICANN on their part could also conduct regular webinars at times convenient to local stakeholder to discuss on relevant issues.

Composition of Working Group on Enhanced Cooperation Announced

The composition of the Working Group on Enhanced Cooperation has been announced by the Chair of the Commission on Science and Technology for Development through the Economic and Social Council in pursuant to UN GA resolution 70/125.

The working group comprises of member states (4 from each region) 5 representatives each from business, civil society, the technical community and academia and intergovernmental organizations.

Along with India being a member state in the working group, Parminder Singh, Executive Director, IT for Change is representing civil society in the working group from the APAC region.

ISOC Announces Newly Elected Board of Trustees

The ISOC Elections Committee has announced the final results of the 2016 selections to the Internet Society Board of Trustees. Desiree Milosevic has been (re-)elected to the board by Organizational Members, Harish Pillay has been elected to the board by Organizational Members, Olga Cavalli has been elected to the board by the Chapter delegates, and the Internet Architecture Board (IAB) has selected, and the IETF confirmed, Richard Barnes to serve as Internet Society trustee, following the process documented in RFC 3677.

The term of office for all of the new trustees will be three years, commencing with the Annual General Meeting of the Internet Society in June 2016.

MAG Open Consultation & Face to Face MAG Meeting

The IGF Multistakeholder Advisory Group (MAG) had their open consultations and face to face meeting in Geneva between 4th -6th April, 2016.

During the meeting it was decided that the annual IGF 2016 would be held from 6-9 December in Guadalajara, Mexico and the main theme and title of the event would be: 'Internet Governance Forum 2016 - Enabling Inclusive and Sustainable Growth'.

Further, Ambassador Benedicto Fonseca Filho was appointed as the Special Advisor to the MAG Chair to assist with outreach efforts within the UN and with senior policy makers.

During the meeting the MAG decided on the timelines for call, evaluation and selection of workshops for IGF 2016. It was decided that the final selection of workshops would be concluded in the next face-to-face MAG meeting (11-15 July).

Further, there was also a discussion on the MAG email list and creating MAG working group that would address, and reflect the MAG's work and working modalities in the context of the CSTD's report on recommendations on IGF improvements. It was also decided to move the broader discussion on creating working groups to a future meeting of the MAG (i.e. an upcoming virtual MAG meeting).

European Parliament Approves General Data Protection Regulation

On 14 April, the Members of the European Parliament approved the General Data Protection Regulation (GDPR), which aims to provide citizens control of their personal data and create a uniform level of data protection across the EU.

Some of the significant provisions of the new rules include, right to be forgotten, clear consent for processing of private data by the person concerned, the right to transfer one's data to another service provider, the right to know when one's data has been hacked, ensuring that privacy policies are explained in clear and understandable language, and stronger enforcement and fines up to 4% of firms' total worldwide annual turnover, as a deterrent to breaking the rules.

This regulation, which is the result of four years of negotiations, also sets minimum standards for use of data for policing and judicial purposes within each member state.

With the implementation of this regulation, EU expects to stimulate the Digital Single Market, by fostering trust in online services by consumers and legal certainty for businesses based on clear and uniform rules.
