



July 2017 At a Glance

The month of July was marked by debates of Net neutrality in US; the US congress announcing to hold a hearing on net neutrality, on 7 September; the right to be forgotten being debated, with France referring the case between the French data protection authority(CNIL) vs Google (Alphabet) to the European Union Court of Justice (ECJ). It was also reported that Mobile broadband penetration reached 99% in OECD area and whatsapp has 230 million daily active users. The month was also marked by various meetings and capacity building initiatives which include events such as IETF 99, AprIGF; APSIG, EUROSIG, etc.

In India, the month of July was marked by the debate on whether "Right to Privacy" is a fundamental right; The Ministry of Electronics and Information Technology (Meity) formed a committee to look into data protection framework; the Jio data leak; the internet population rising to 422.2 million; Uber announcing completing 500 million trips in India in 4 years and 5 million active weekly trips; the Department of Telecom (DoT) rejecting the pleas from the Indian Cellular Association (ICA), and sticking to its original deadline of January 1, 2018 for compulsory inclusion of GPS systems in all mobile phones. Further, the Indian Computer Emergency Response Team (CERT-In) reported that India witnessed around 27482 cyber security threat incidents and 37 incidents of ransomware attacks till June 2017. CERT-In and its Bangladeshi counterpart Bangladesh Government Computer Incident Response Team (BGD e-Gov CIRT) signed a Memorandum of Understanding (MoU) on cyber security cooperation..

AprIGF 2017 Update

The Asia Pacific Regional Internet Governance Forum (APrIGF) 2017 was held at Chulalongkorn University, Bangkok from 26 - 29 July 2017. The theme for this year was " Ensuring an Inclusive and Sustainable Development in Asia Pacific: A Regional Agenda for Internet Governance". The meeting was attended by 550 people, including a diverse group of 50 fellows and the conference program consisted of three parts: the "pre-event" meetings, the "core conference," and the "Youth IGF Camp."

During the closing ceremony Mr. Rajnesh Singh, who was appointed the MSG Chair (2017-2019), took charge from Paul Wilson, while Ms. Sylvia Cadena was appointed as MSG Vice-chair (2017-2019).

Comments were invited to the APrIGF 2017 Bangkok Synthesis Document, which aims to document the inputs of participants at the AprIGF, till 4 August 2017.

At the event CCAOI Director moderated a session "Universal Acceptance: An Elixir to Inclusive and Multilingual Internet."

The [Asia Pacific School of Internet Governance \(APSIG\) 2017](#) was held from 22-26 July 2017 at Sukosol Hotel, Bangkok. 51 onsite and remote participants from 22 countries attended the school this year. These include: 9 lecturers, 3 SIG Representatives, 4 Coordinator/ Session Chair, 2 APTLD Fellow, 25 General Participants, 2 Administrative Staff and 6 Remote Participants. ICANN Updates

During the month of July, ICANN [published](#) the updated gTLD Marketplace [Health Index](#), which presents statistics and trends related to generic top-level domains (gTLDs); announced a [request for proposal](#) (RFP) for conducting an independent assessment of the Security and Stability Advisory Committee (SSAC); [published](#) the Findings of ICANN59 [Community Feedback](#) and the Numbers Reports; organized a [webinar](#) to review findings of the WHOIS Accuracy Reporting System June 2017 Report published 12 June 2017; [sought mentors](#) for the Global Indigenous Ambassador Program.

The Registry System Testing (RST) Site [went Live](#) and the published information can be accessed from this [link](#) . 31 July, 2017 was the [effective date](#) of the Approved Amendment to the Base New gTLD Registry Agreement. The Security Framework Drafting Team [announced](#) to present the draft Framework for Registry Operators to Respond to Security Threats.

Further, the list of successful candidates for [ICANN60 Fellowship](#) and [NextGen](#) was announced. 60 individuals from 50 countries have been selected to participate in ICANN's Fellowship program, while Fifteen individuals

from various universities in the Asia-Pacific were selected for the NextGen program. The deadline has been [extended](#) for Request for Proposal for the SSAC Organizational Review to 21 Aug 2017

APAC update

Internet Society Updates

This month Internet Society launched the reports on the fourth annual Internet Society Survey Report on Internet Policy Issues in Asia-Pacific, and [impact of the Internet on societies](#) ; invited applications for the [2017 Ambassadors to the Internet Governance Forum](#) (IGF) and [IETF100](#) till 6 August, 2017; announced the names of 4 awardees for the Internet Society (ISOC) [Fellowship to the 2017 World Telecommunication Development Conference \(WTDC-17\)](#).

Internet Society also collaborated with collaboration with Pakistan Telecommunication Authority (PTA), Ministry of Information Technology and Telecom (MoITT) and Higher Education Commission (HEC) organized "Pakistan Digital Forum 2017" (#PakDF2017) on 19 July, 2017.

Internet Society Chennai, organised an [event](#) on DNSSEC / KSK on 9 July, 2017, followed by a round table discussion on the policy aspects of DNS Security.

Internet Society also hosted the The APriGF Bangkok 2017 Closing Social on 29 July, 2017.

APNIC Highlights

This month, APNIC participated in various regional events such as the [3rd INTERPOL Global Cyber Crime Expert Group \(IGCEG\) meeting](#) in Singapore from 5 -7 July 2017; the [20th Pacific Network Operators Group \(PacNOG\) meeting](#) held in Suva, Fiji, from 3 - 7 July 2017; APSIG 2017 held in Bangkok between 22 -26 July, 2017; [APriGF 2017](#) held in Bangkok between 26-29 July, 2017. Besides APNIC delivered a [three-day Internet Resource Management and Network Security workshop](#) from 24 - 26 July 2017, in Honiara, Solomon Islands.

In July, APNIC and FIRST cemented their [collaboration in security](#); the Australian Government provided an initial AUD 100,000 [grant](#) to the APNIC Foundation to continue the development of national CERTs in the Pacific.

Also, there was an [invite for policy proposal](#) for APNIC 44; the nomination period for the [Number Resource Organization Number Council \(NRO NC\) election](#) was open till 10 August; the Chairs of the Cooperation Special Interest Group issued a call for presenters on a security theme for its meeting at APNIC 44. Interested proposals can be sent to sig-cooperation-chair@apnic.net before 18 August, 2017.

Further, the 50 recipients of the APNIC 44 Fellowship was [announced](#), the list includes 24 women and 26 men; and the APNIC Academy launched its their second course: '[Internet Resource Management](#)', which is meant for anyone interested in managing their Internet number resources more effectively, familiarising themselves with the Internet ecosystem, and finding out new ways to engage with the Internet community.

TRAI Updates

This month TRAI released their recommendations on "[Issues related to Closure of Access Services](#)". TRAI also released the [Yearly Telecom Services Performance Indicator Report for the Year, 2016](#). The [Indian Telecom Services Performance Indicator Report for the Quarter ending March, 2017](#) released by TRAI, mentioned that the total number of Internet subscribers has increased from 391.50 million at the end of Dec-16 to 422.19 million at the end of Mar-17, registering a quarterly growth rate of 7.84%. Out of 422.19 million, Wired Internet subscribers are 21.58 million and Wireless Internet subscribers are 400.62 million.

Further, the authority [extended the comment submission period](#) for the consultation paper on [Data speed under wireless broadband plans](#) upto 3 August, 2017.

Further, in the month of August, TRAI and The International Telecommunication Union (ITU) and are jointly [organizing](#) the "ITU-TRAI Asia-Pacific Regulators' Roundtable" and the "ITU-TRAI International Training Program (ITP) 2017" during 21-22 August and 23-25 August 2017 respectively in New Delhi, India.

IETF Highlights

[IETF 99](#) was held in Prague, Czech Republic between 16-21 July, 2017. The meeting was attended by 1230 participants and around 506 remote participants. 6 individuals from India participated in person and 38 remotely.

The Indian delegation to the meeting was led by Mr. T. Santhosh, Scientist “E”, MeitY. The other Indian representatives at the meeting include IREF Fellows Harish Chowdhary and Balaji; Internet Society Fellows Mohit Batra and Abhijaan Bhattacharya and Sunil Abraham from The Centre for Internet and Society. In the Internet research Lab (IRL), National Internet Exchange of India (NIXI) presented an [Internet draft](#) describing the initiatives been taken to set up an experimental internet research lab in India

Further for encouraging more participation at IETF from India, IIESOC supported by Council of Information Security (CIS) organized an IETF India Community dinner, which was attended by 25 members.
